Ms. Cabanillas and Mr. McWhirter are frequent lecturers on issues of constitutional and criminal law, with expertise in Fourth Amendment issues. Ms. Cabanillas is an Assistant U.S. Attorney in the Appellate Division of the U.S. Attorney’s Office, where she previously served as Appellate Chief, Deputy Appellate Chief, International Coordinator, Training Coordinator, and a Trial Attorney in the Criminal Division. She also served as an Assistant Director for the Department of Justice’s Office of Legal Education. Mr. McWhirter is a Certified Specialist in Criminal Law with the State Bar of Arizona and first chair qualified to defend capital cases by the Arizona Supreme Court. He is in private practice focusing on criminal defense and serves on the CJA panel for the District of Arizona. He previously served as Training Director for the Pima County Public Defender, Chief-of-Party implementing the USAID contract for Improving the Justice System in El Salvador, Senior Attorney in the Maricopa County Defender’s Office, an Assistant Federal Public Defender, Supervising Criminal Attorney for the ASU Alumni Law Group, and as a visiting and adjunct professor of law. They have both written extensively on constitutional criminal law issues and published several books and articles, including the Arizona State Bar publication, SEARCH & SEIZURE: A PRACTICE MANUAL, by Ms. Cabanillas, and BILLS, QUILLS AND STILLS: AN ANNOTATED, ILLUSTRATED, AND ILLUMINATED HISTORY OF THE BILL OF RIGHTS, by Mr. McWhirter.
